The following phone call was received from Robert Yount @ 08-13-2010, 07:00 p.m.

This is an Official Call - For The Governor, Subject to Subpoena

If security operations in this state (Missouri) were functioning properly, President Obama in his most recent speech in the Oval Office, would not have gone there and used the term "epidemic" in the course of his speech (June 15, 2010 Remarks by the President to the Nation On the BP Oil Spill).


